Cookie policy

What are cookies?

Cookies are small files that store information in your browser and are commonly used to distinguish individual users. However, this information cannot be used to identify the user.

What do we use cookies for?

- To optimize functionality.
- To determine which pages and features are most frequently visited by users.

What cookies do we use?

The cookies used on our website can be divided into two basic types in terms of their duration. Short-term “session cookies,” which are only temporary and remain in your browser only until you close it, and long-term “persistent cookies,” which remain on your device much longer or until you manually delete them (the length of time cookies remain on your device depends on the settings of the cookies themselves and your browser settings). In terms of functionality, each cookie can be divided into:

- analysis files, which help us improve the user experience of our website by understanding how users use it,
- essential files, which are important for the basic functionality of the website.

Some cookies may collect information that is then used by third parties and which, for example, directly supports our advertising activities (so-called “third-party cookies”). However, you cannot be identified based on this information.

The cookies we use allow us to improve our website.

GDPR
